Voting Period

The ballot, if required, will open on Monday 10 November 2025 and close at 10am Australian Eastern Daylight Time (AEDT) on Monday 8 December 2025.

The appointment of scrutineers opens Monday 29 September 2025 and closes 10am AEDT on Monday 8 December 2025.

A form is available from the Returning Officer for the purposes of appointing Scrutineers.
